You are invited to participate in the 42nd annual Buffalo Chamber's Art & Craft Festival on Saturday, August 16, 2025, from 9 am - 3:30 pm, in the streets of downtown Buffalo, Minnesota. Even though this is a long standing event, we promote it heavily locally and via social media and email. It's always a great turn out of exhibitors and guests!

Attached you will find an application, policies and regulations and a ST-19 form. *Please complete and return your application, ST-19, and payment by July 25th, 2025.*

ALL NEW exhibitors to our Festival must submit photos of their items and work station. Only handcrafted items made by you will be allowed. If you were a vendor in 2023 or 2024 you need not send photos but a ST-19 is still required.

Returning Exhibitors Only: If you are a returning crafter you have the option to register and pay **online**. You will need to email your ST-19 to us. Visit us at [BuffaloChamber.org](http://BuffaloChamber.org). To register and pay online.

Booth space will be reserved when your application and payment have been received.

If accepted, your booth number/location will be mailed to you on August 9<sup>th</sup> along with maps regarding access and parking. We ask that you look at your space and come early if in the middle of any street. Come later if at an end. We make every effort to make coming and going a smooth process.

If you attended last year, the setup will be the same covering more city blocks with space between tents.

## 2025 Policies and Regulations

The Festival runs down the middle of two streets - Division Street and 1<sup>st</sup> Avenue in downtown Buffalo.

1. Art and craft items of original design and handcrafted by the vendor are the only merchandise allowed to be sold.
2. All Items **MUST BE** handcrafted. Items manufactured and purchased for resale are not permitted (buy/sell items). Not allowed are items made from kits, raffle tickets, screen prints of non-original designs, and picture frames with commercial reproductions (except framed prints which are limited edition, visibly signed and numbered – artist must be present).
3. No consignment items or assembled items that shoot neither a flying projectile nor imported items produced outside of the United States are allowed.
4. Set up time begins at 6 am and ready to sell by 9 am. Tear down is at 3:30 pm. If you set up prior to 6 am, you may be asked to move your booth if it is not in the correct location.
5. Your 10 ft. space is designated by two strips of pink duct tape with a numbered sign in the middle of the two strips of tape and a line of twine running down the center of the road. Tents will be spread out, with the festival covering more city blocks.
6. Extra-large and/or extra heavy booth items and vehicles are required to set-up between 6-7 am.
7. All vehicles are to be parked in the designated areas by 8:45 am.
8. You are to provide your own canopy, table, electricity, chairs and supplies. Generators are not permitted.
9. All items (storage or display) must remain within your designated booth space. Items are not allowed in walking area.
10. **NEW Exhibitors Only:** Please submit photos of product(s) and work station showing raw materials. Digital photos may be submitted via email. Photos will not be returned. Once they are received they will become property of the Buffalo Area Chamber of Commerce. Declined applicants will be notified within three weeks upon receiving your application. **JUDGES WILL BE WALKING THROUGH THE SHOW THE MORNING OF AND IF THEY FIND YOUR ITEMS ARE NOT HAND CRAFTED YOU WILL BE ASKED TO LEAVE.**
11. Booth location and show information will be mailed early August, including a map showing your assigned space. We will do our best to honor booth location requests, however, your request is not guaranteed.
12. Booth space will be reserved when all applicable fees and forms have been properly submitted. We will not hold space without payment, a completed and signed application and a ST-19 form. **Application, ST-19 and payment must be received by July 25th.** Applications received after July 7, 2025 will be charged a late fee of \$25.00. No show policy: If you are unable to attend the show please contact the Chamber up to two days prior to the show. Lack of notification may affect your acceptance to future shows.
13. The show will proceed regardless of the weather (wind, rain or heat).
14. Do not block any entrance to a business; many are open on Saturday.
15. You must remove your own trash at the end of the show.
16. A \$30 processing fee will be charged for checks returned by the bank for non-sufficient funds.
17. \$50 (per booth) is non-refundable up to July 25th. There will be no refunds for cancellations after July 25th.
18. Buffalo Area Chamber of Commerce has the right to refuse an application.

**Sales Tax:** We are required to notify crafters that they must have a Minnesota Sales Tax number and collect and pay 6.875% Minnesota Sales Tax. APPLICANTS MUST INCLUDE A COMPLETED ST-19 FORM (each year) WHICH WE ARE REQUIRED TO HAVE ON FILE FOR EVERY CRAFTER. This form is attached and more information about event sellers can be accessed at [www.revenue.state.mn.us](http://www.revenue.state.mn.us).

**Violations:** Any violation of the Policies and Rules, Minnesota Sales Tax Law, Buffalo City Ordinance, or a material misrepresentation on the application shall suffice for the Buffalo Chamber to elect to immediately close down the crafter and/or deny them the right to return to the Buffalo Art & Craft Festival in the future.
